Law firms face unique risks when operations are disrupted:



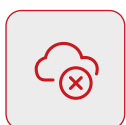
### Missed Deadlines

- Multiple storage locations—both cloud and secure offsite—ensure data is recoverable after a localized event.
- Frequent testing of backup integrity to ensure recoverability when needed.

### Disaster Recovery Planning

- Clear, documented procedures for restoring IT systems after an outage.
- Defined recovery time objectives (RTOs) and recovery point objectives (RPOs) tailored to each practice area's needs.
- Redundant servers and failover systems to minimize downtime.

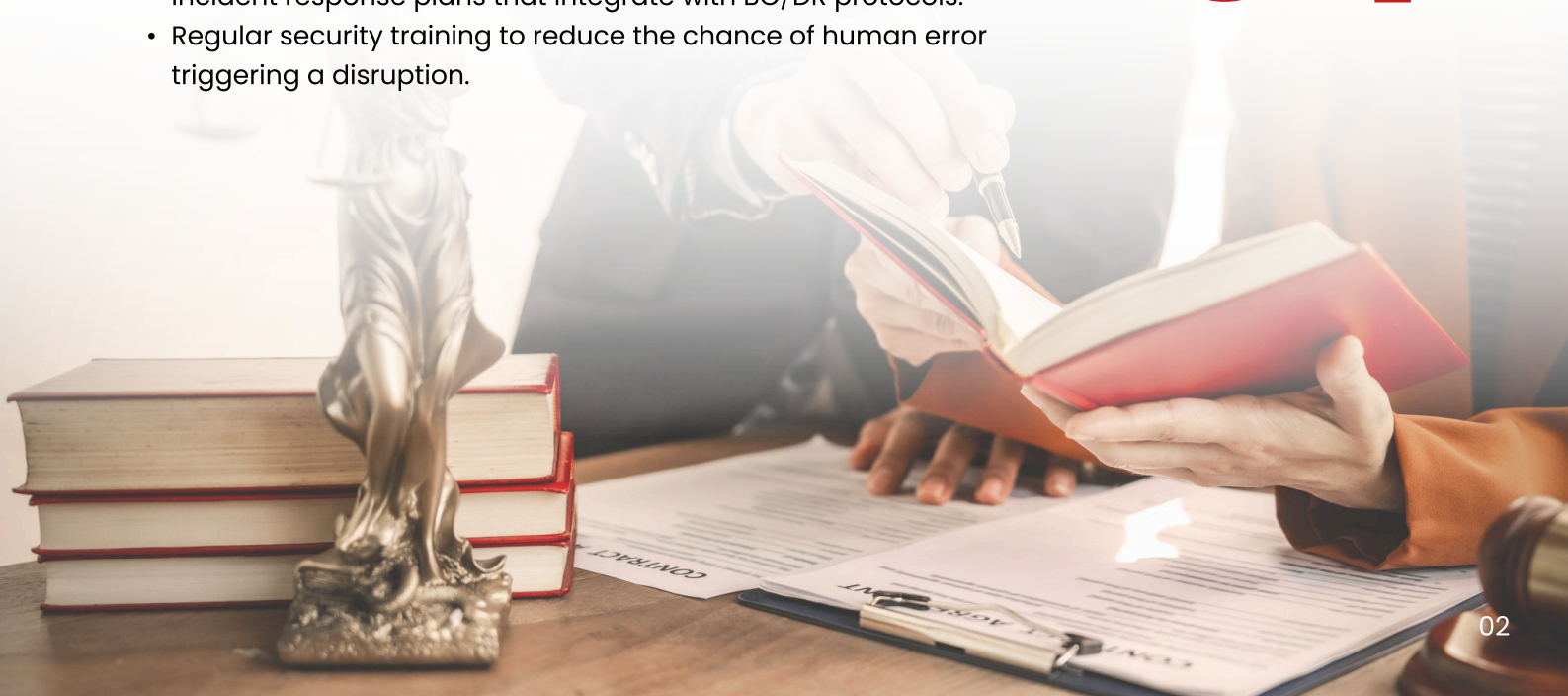
### Business Continuity Measures

- Remote work capabilities with secure VPN and cloud-based access to practice management tools.
- Communication plans that include alternate channels if primary systems are down.
- Role-specific continuity plans so each team member knows their responsibilities during disruptions.

### Cybersecurity Integration

- Strong perimeter defenses and endpoint protection to reduce the risk of ransomware and other attacks.
- Incident response plans that integrate with BC/DR protocols.
- Regular security training to reduce the chance of human error triggering a disruption.

### Document Everything

### Train Staff Regularly

Conduct annual training so all employees know their role during an incident.



### Leverage Cloud Solutions

Use cloud-based practice management and storage tools for accessibility during local outages.



### Test and Update

Run simulated outages and recovery drills at least twice a year, adjusting plans based on lessons learned.



### Prioritize Critical Functions

Identify which systems and operations must be restored first to resume essential legal work.
